

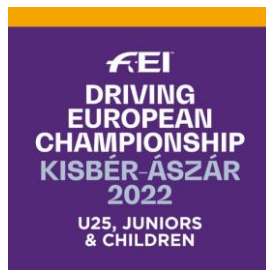


Dear sir, madam,

Thank you very much for your entry for the FEI Driving European Championships for Children, Juniors and U25 in Kisbér-Ászár from 16th to 21st August 2022.

Please find underneath important information about the Championships.

- The program can be found on [Hoefnet](https://www.hoefnet.nl). Tentative starting orders and other important information will also be published on the website. Please keep in mind all information is subject to change. All other official communication will be done via the WhatsApp group of the Chefs d'Equipe.
- Arrival is possible from 12.00pm Monday 15 August. **Earlier arrival is not possible.**
- The veterinarian and steward team is present to welcome you between 12.00pm and 20.00pm on Monday and 8.00am and 15.00pm on Tuesday.
- If you arrive outside these hours (**but not before 12.00pm on Monday!**) please inform the Show Office: +36 30 9028632 (Krisztina Horváth).
- **Make sure that you have the result of the test to Equine Infectious Anaemia (negative Coggins Test) not older than 12 months registered in the passports of your horses.**
- **Take your horses'/ponies' temperature twice daily 3 days before coming to Kisbér-Ászár! If you arrive on Monday 15 August, you have to start registering temperature in the FEI HorseApp from Friday 12 August on. Make sure you fill the Horse Health Self-certification form before arrival and bring your own thermometer with you!**
- The Examination on Arrival will be done by the FEI Treating Veterinarian before you enter the stables. This is where your horses'/ponies' passport(s) will be collected by the stewards.
- First bedding (straw) will be provided. Thereafter straw tickets can be purchased at the Show Office and can then be obtained from the Stable Manager during the fodder hours. Only pre-ordered shavings are available. **Hay is not available.**
- The manure disposal (€40 per box) must be paid in cash upon arrival in the Office, through the Chefs d'Equipe. The amount will be refunded if the boxes are cleaned before departure.
- Every competitor will receive a parking space of 7x20m. This includes space for one additional caravan or camper van for the Chef d'Equipe or team veterinarian. 1 electric hook-up per competitor is included in the entry fee.
- There is no restriction on the use of (electric) bicycles.
- Please bring your own bridle numbers and carriage numbers.
- The marathon obstacles will be officially open on Wednesday 17 August after the approval of the PGJ and TD. Exact times to be communicated via WhatsApp.
- Please note that only cones provided by the Organizing Committee are allowed.
- There is a supermarket at walking/cycling distance from the showground.
- Euros are accepted on the showground. There is a cash machine on the showground.
- Dogs on the leash at all times. No open fires on the premises.
- Due to the extreme dry weather and fire risk, smoking is **NOT** allowed on the entire showground, including the camp site. Designated smoking areas will be allocated. The filling up of swimming pools is not possible because of water shortage due to drought.
- All drivers are taking part in the event at their own risk. The OC does not take any responsibility for any accident or illness that may befall any horse, competitor, groom or any other person.



Dear Drivers,

The OC is extremely happy to welcome you once again on their showground in Kisbér-Ászár for this amazing Championship. However, as you all may know and experienced, Europe and Hungary are in very difficult times. The war in Ukraine extremely affects our economy and therefore our energy sector is having a huge crisis. This is visible in the heavy fuel restrictions, such as fueling in cans is basically not possible or in very limited quantities. Also, this means that the available energy for organizers and operation of heavy generators is not possible. We kindly ask you to think about the usage of electric equipment during the show, such as heavy consumption grills, air conditioners etc. If that is not considered, we might be forced to apply some restrictions in order to protect the necessary use of power for all. It is also necessary that all equipment is safe and up to standard, as the security system of the power box is not tolerating overload, or broken connections, and can cause discomfort for everyone. If you feel that it is necessary to use extreme consuming equipment, such as air conditioners, or grills, we suggest to bring your own power generator for back up. We wish to remind you, that the maximum amount of fuel is 20l/day that can be purchased in cans, and 50l/day in cars. Naturally the OC is providing power and electric to all participants, and this message is just a kind request and advice.

Thank you for your understanding and consideration.
